Our Rolling Hills Riviera Neighborhood Association is a member of The Rancho Palos Verdes Council of Homeowners Associations (CHOA), which brings together many RPV HOAs (both formal governing associations and voluntary associations such as ours). CHOA has informative speakers at their meetings on issues such as pending legislation in the State Legislature affecting local control of housing density and zoning. One of our Board members, Glenn Cornell, sits on the CHOA Board, and Board members Mike Bilinski and Elizabeth Hoffman attend the valuable meetings. The next CHOA meeting is June 17th, if you'd like to go.

One of CHOA's priorities is emergency preparedness. CHOA is sponsoring, along with the City of RPV, a Wildfire Resource Event on Saturday, May 30th 9am – 3 pm at UCLA South Bay Campus, 30800 Palos Verdes Dr East. There will be informative presentations, vendor and government booths, and free giveaways.

CHOA is distributing pool placards as part of the LA County Fire Department's program for placing placards at properties with swimming pools that could provide fire-fighting personnel with additional water in emergency
